Need to discuss upcoming events, Finances, and how we will proceed. Melissa Weldon asked how many scholarships we have from donations. Dawn Soukup reported that it is 2480 just about enough for two scholarships.

Dawn Soukup asked about who was using their care package refund for registration. Kathy Hemann will forward the spreadsheet with the breakdown to Dawn Soukup and LaDonna Nobbe.

Rhonda scholarships:

23 applicants in total. Several did not meet all the required qualifications. The scholarship recipients have not been notified yet. Funds collected for Dianne Grey went to NWHC General fund. The scholarship will be titled: In loving memory or Diane Grey. University was contacted for endowed scholarships. The scholarship breakdown is as follows: 6 out of the endowments, 1 in memory of Diane Grey, 2 from donations. Leaving 3, for a total of \$3750, that will be pulled out of the general funds. LaDonna Nobbe asked if we were going to look at reducing the number of scholarships this year.

LaDonna Nobbe asked about donations to school organizations. What amount would be going to them? She also mentioned that we need to account for the book award scholarships in May as well.
